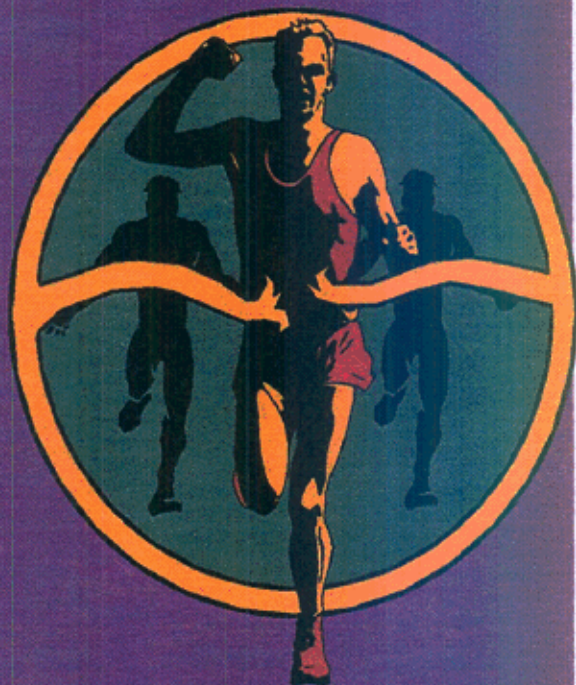

# "2011 CCS FUND RUN/WALK"

Community Christian School has operated in Scottsbluff since 1988 and is currently located in the old Bryant Elementary School Building. The 2011 CCS FUND Run/Walk is a fundraiser designed to raise money for the purchase of land and the construction of a new school at the corner of Hwy 71 and Hwy 92 in Gering.

Today the school has more than 200 students attending K-8 grades. While the 8th grade graduates are highly prepared for high school, proponents see an immediate need for a Christian-based K-12 school in the Valley. It is expected the new school will attract students from Kimball, Torrington, Wyoming, Hemmingford, as well as Gering and Scottsbluff.

The new school, including a high school, would offer many extracurricular activities including speech, chorus, band, football, volleyball, basketball, and track to facilitate teaching the "whole child"...mind, body, spirit...to be successful.

2. All runners/walkers under 18 years of age must have the form signed by a parent or guardian.
3. All children must be accompanied by a parent or guardian at all times. Requires parent/guardian approval on Liability Waiver.
4. All participants should be aware of faster runners approaching from behind. Please allow room for them to pass safely.
5. A faster runner will announce his/her presence and intent to pass on the left or right by saying "on your left"...if passing on the left...or "on your right"...if passing on the right.

**(Don't forget sunscreen and necessary medications such as inhalers and the like.)**
